# **Towson University Music Education Program Interview Requirements**

**Applicants:** B.S. Music Education Sophomores / Juniors

All music education students are considered candidates for the B.S. in Music Education degree for Maryland State Department of Education (MSDE) teacher licensing (certifying students to teach music at the PreK-12 level in Maryland Public Schools and other states with reciprocal agreements) until they apply to and are admitted into the Music Education degree program, and must meet the following Music Education requirements for acceptance into the Program.

# **Requirements:**

#### **GPA**

\*Earned 3.0 cumulative GPA for all post-secondary institutions attended. Earned 3.0 GPA in Music Education major courses.

\*If you **do not** have a GPA of 3.0 at the time of application and you would like to be considered for conditional admission (and your GPA is between a 2.5-2.99), then you will need to provide evidence of passing one of the basic skills requirements below at the time of application.

# **Applying for Music Education Program Admission**

Applications for MUED Program Admission are carried out through an online application process via the Watermark system. Instructions for this Music Education Application have been provided to Pre-MUED majors for the Spring 2025 term, with Interviews late March.

Items needed for a complete application, Spring 2025:

- ➤ Professional References two (2) professional references and their email addresses
- ➤ Academic History
  - > Current Cumulative GPA (as per MUED Program requirements)
  - > List of all other colleges and universities attended and GPA, along with the degree and date degree received
- ➤ EPP (Educator Preparation Provider) -Wide Required Documentation
  - > Unofficial Towson University Transcript
  - > Unofficial Transcripts of Other Colleges and Universities Attended
  - > Criminal History Disclosure Statement (link will be provided)
  - > Professional Behavior Policy Education Student Acknowledgement Form (link will be provided)
- ➤ MUED Program-Specific Required Documentation
  - > GPA Calculation Spreadsheet (form will be provided)
  - > Short Narrative detailing why you want to become a music educator
  - > Video link for an acapella children's song (for example, 'Twinkle, Twinkle, Little Star')

# After Full Admission into the Music Education Program

- Must maintain a 3.0 cumulative GPA. If it dips below 3.0, you have one semester to get it back up to 3.0 before you are dismissed from the Program.
- All 400-level MUED courses require admission into the MUED Program in order to enroll.

# **Course Fees Associated with Music Education Program**

- MUED 211: \$100
- ➤ Practicum courses MUED 404, 406, 408, 410 have a course fee of \$50. This is a stipend for your mentor teachers.
- > Full-time Internship courses have the following course fees:
  - > MUED 491 \$250 (mentor teacher stipend)
  - > MUED 492 \$250 (mentor teacher stipend
  - > 1st rotation MUED 491 or MUED 492 \$300 (edTPA national scorer fee)

# **Practicum Hour Changes** (amount of time you are working with mentors in schools)

Effective fall 2024 requirements were to spend 2 (two) full days in Practicum part-time placements. By 2025 180 full days will be required, spread across junior and senior years.

#### Recitals

Music education majors are not required to perform a senior recital but may request to do so by contacting Dr. Terry Ewell, Interim Chairperson Spring 2025 (<a href="tewell@towson.edu">tewell@towson.edu</a>) and Dr. Alicia Mueller (<a href="teamueller@towson.edu">tewell@towson.edu</a>). You must have permission from your applied instructor before submitting your formal request to Drs. Ewell and Mueller. Obtain the "Recital Authorization Form" AND "Student Degree Recital Reservation Form" (available on the music website) and complete, along with your applied teachers, before submitting. Students must turn in these forms no later than Tues., May 20, 2025. A confirmation mail will be sent to the student and applied instructor, along with the other faculty member(s) who will be attending the recital.
